STADIUM OLIMPICO DI ROMA RULE OF CONDUCT AND TERMS OF USE

(Article 1-octies of Decree Law 28/2003, converted and amended by Law 88/2003)

These Stadium Regulations, issued pursuant to Article 1-octies of Decree Law No. 28/2003 (converted into Law No. 88/2003), govern access to, presence within, and behaviour inside the sports facility where the event takes place.

"FIR" refers to the Italian Rugby Federation.

"Event" refers to any sporting event held at the Stadio Olimpico di Roma and organized and/or managed by the FIR.

The term "sports facility" refers to all relevant areas, including the outdoor areas reserved for event operations.

Access to and presence within the sports facility for any reason during events are regulated by these Terms of Use. The purchase of a ticket constitutes full acceptance of these Terms.

Failure to comply with these Regulations will result in the immediate termination of the service contract, removal from the facility, and the application of any penalties provided for by the competent authorities. If the offender has already been sanctioned during the same sporting season – even at a different venue – for the same violation, the penalty may be increased by up to half of the maximum, and an access ban to sporting events may be imposed.

PLEASE NOTE:

- Tickets for the Event are non-nominal: the name printed on the ticket is that of the purchaser, not the holder. Tickets may therefore be transferred to third parties in accordance with the organiser's regulations and sales policies. Any illegal admission tickets will be confiscated by security personnel with police assistance.
- During entry checks, spectators may be asked to show a valid identity document in addition to their ticket. This must be presented upon request.
- Tickets must be retained until leaving the stadium.



- The organiser accepts no responsibility for tickets purchased through unofficial online platforms that are found to be invalid at entry.
- Spectators must occupy only the seat assigned to them. They may not occupy a
 different seat, even if vacant, unless expressly authorised by the FIR.
- Children aged 3 or over may only enter with a valid ticket. Children under 3 may enter free of charge, provided they do not occupy a seat.
- Spectators are subject to security checks, including metal detector screening, and must comply with instructions given by security personnel.
- For security reasons, the Public Safety Authority may restrict or prohibit entry even for holders of valid tickets. Persons subject to sports-related conduct bans may not access the stadium under any circumstances.
- The FIR is not liable for loss, accidents, or damage to persons or property within the stadium or event area, unless directly attributable to its negligence.
- The FIR cannot guarantee that the match will take place on the scheduled date or time and reserves the right to reschedule without prior notice or liability.
- In the event of postponement or cancellation, refunds will be issued according to the terms of the ticket purchase contract. Refunds or replacements will only be made upon presentation and return of the ticket.
- Any spectator found in a section other than that indicated on their ticket will be escorted to their assigned seat.
- Spectators must not remain standing during the match, as this may obstruct the view of others and compromise safety by blocking aisles or escape routes.
- By purchasing a ticket, spectators acknowledge that they may be subject to security checks. Refusal to comply will result in denial of entry or expulsion.
- The area inside and around the stadium is subject to audio-video surveillance carried out by Public Security authorities in accordance with applicable legislation.
- The FIR is not responsible for loss, accidents, or damage to items deposited in storage areas managed by third-party providers.

Stadium Opening

The stadium opens 2 hours and 30 minutes before kick-off. This information will be announced in advance on official FIR channels, stadium LED screens, and the public address system.



To ensure smooth access, spectators are strongly advised to reach their designated section at least 45 minutes before kick-off. The FIR accepts no liability for delays affecting spectators who do not follow the provided instructions.

PROHIBITED BEHAVIOURS:

The following are strictly prohibited:

- Entering the stadium with inflated rugby balls, pushchairs, trolleys, or bulky items that may obstruct visibility or evacuation routes.
- Any form of racial, ethnic, or religious discrimination, including through chants or written messages.
- Standing in aisles, passages, entrances, access routes, or escape routes without valid reason.
- Climbing structures, fences, or barriers.
- Accessing or occupying a sector different from that indicated on the ticket.
- Damaging, tampering with, or interfering with stadium structures, infrastructure, or services.
- Bringing in poisons, harmful substances, flammable or staining materials, or drugs.
- Introducing or selling alcoholic beverages with an alcohol content above 5%, except where specially authorised.
- Bringing in stones, knives, or any objects that could cause injury, be thrown, or pose
 a danger; or bringing sound or light-emitting devices (including laser pointers).
- Displaying materials that obstruct visibility, signage, or escape routes.
- Bringing beverages in cans, glass bottles, or plastic bottles (contents must be poured into cups)



 Displaying banners, signs, flags, drawings, documents, or printed material not expressly authorised.

Authorised banners may only be displayed in designated areas and must be removed at the end of the event.

Authorisation for Choreographic Material

To display banners or choreographic materials, spectators must obtain FIR authorisation and GOS approval at least 10 working days before the event by emailing sicurezza@pec.federugby.it with personal details and ID.

Further Prohibited Actions

- Organising unauthorised choreography or modifying previously approved choreography.
- Entering or remaining in the facility while intoxicated or under the influence of drugs.
- Bringing helmets, umbrellas with rigid tips, or any object deemed dangerous.
- Parking vehicles outside designated areas.
- Conducting commercial or promotional activities or collecting donations without authorisation.
- Improper disposal of waste.
- Any actions that, in the judgment of security personnel, obstruct the event or endanger others.
- Bringing animals, except guide dogs or trained rescue dogs.
- Standing on seats.
- Entering restricted areas.
- Re-entering the facility after leaving, unless holding specific invitations for postmatch ceremonies.



- Introducing rigid or non-flexible flagpoles.
- Introducing drones or remote-controlled aircraft.
- Bringing musical instruments without authorisation.

REASONS FOR EXPULSION:

Expulsion will occur for anyone who:

- · Acts violently, abusively, or offensively.
- Discriminates on ethnic, religious, or political grounds.
- Engages in political propaganda.
- Damages the facility.
- Behaves in a way that endangers public safety.
- Enters without a valid ticket.
- Blocks access or escape routes.
- Displays unauthorised banners.
- Introduces prohibited materials.
- Violates any clause of these Regulations.

CRIMINAL OFFENCES:

The following actions constitute criminal offences:

- False statements or misrepresentation.
- Possession of weapons or improvised weapons.
- Display of emblems or symbols promoting discrimination or violence.
- Incitement to violence during sporting events.
- Possession, use, or throwing of dangerous materials or pyrotechnic devices.
- Climbing barriers or invading the pitch.

The facility is monitored inside and outside by audio-video systems in accordance with applicable privacy laws.



ANTI-INFRINGEMENT POLICY:

It is strictly prohibited to use electronic devices to record, transmit, produce, or distribute audio, video, or data relating to the match for betting or unauthorised commercial purposes. Mobile phones may only be used for strictly personal purposes.

Non-compliance may lead to denial of entry or removal from the facility.

OTHER EVENTS ORGANISED BY THE FIR:

Choreographic or communication materials introduced by the FIR for institutional, promotional, or marketing purposes do not require GOS authorization, provided they remain within the sports facility and its related areas.

PRIVACY NOTICE:

The stadium is equipped with audio-video surveillance systems both inside and outside. Data is processed by the controller in accordance with Legislative Decree No. 196/2003 and the Ministerial Decree of 6 June 2005, in full compliance with applicable law.
