REGULATION OF USE III TIME

COMMERCIAL AREA "III TEMPO"

RULES OF CONDUCT AND RULES OF USE

These Regulations for the use of the "III Tempo" commercial area, provided for by the organizer, are aimed at regulating access to and stay within the area of the Foro Italico Park where the event takes place, as well as the good rules of conduct to be followed.

By FIR or Federation, we mean the Italian Rugby Federation.

Event means any sporting event that takes place in the "III Tempo" commercial area - at the Foro Italico Park, organized and/or managed by the Federation.

Pursuant to these regulations, the III Tempo commercial area means a place of meeting, belonging and socializing, coinciding with the perimeter area outside the stadium, which extends from Via dei Gladiatori, Viale delle Olimpiadi, Largo De Martino, including the area of the Stadio dei Marmi and Piazza Dodi.

Access and permanence, for any reason, within the III Tempo, on the occasion of events, are regulated by these "regulations of use"; The purchase of the ticket implies its acceptance by the spectator.

Failure to comply with the same will result in the immediate termination of the service contract, with the consequent removal of the offender from the plant as well as the application of the sanctions provided for by the body competent to impose them, if it is a violation of the requirements imposed by law or regulations in force.

To ensure everyone's safety and serenity, the following simple rules of coexistence within the area must be respected.

- Within the area there are highly specialized medical facilities, take a look at the signs specially prepared for their location.
- The Third Time takes place within an area of high historical monumental value, so it is strictly forbidden to damage or tamper with structures, infrastructures, toponymy signs, green areas and services in the area in any way.
- For waste disposal, use the appropriate containers to maintain the decorum of the area.
- Only commercial, food and beverage and advertising activities that have been duly and previously authorised may be carried out; Any abuse will be prosecuted in accordance with the law.
- Do not place containers in cans or glass of any kind inside the area
- It is forbidden to bring animals of any kind, unless expressly authorized.
- It is forbidden to introduce drones or remotely controlled flying objects of any kind and class;

- It is forbidden to introduce and use any dangerous, stinging, spray, soiling substance such as paints or solvents;
- It is forbidden to introduce accessories or aids that may endanger the safety of the event (e.g.: umbrellas with sharp tips, knives for food consumption, etc.).
- To allow a regular influx, it is advisable to enter the stadium at least 45 minutes before the start of the meeting.
- Balloon throwing and other recreational activities are only permitted in specially designed areas.
- The entry of any motorized wheeled vehicle is prohibited; The access of other wheeled vehicles will be allowed after verification by the security personnel.
- Do not stop near passages, sorting routes, exits, entrances, along access routes, escape routes and any other escape route.
- Do not climb on balustrades, parapets, partitions and other structures not specifically intended for public parking.
- Respect the opening hours of the Village: opening, closing and temporary suspension of some activities
- Maintain an appropriate and respectful behavior for all activities and operators present.
- The companions of the athletes and the public in general, who want to attend the recreational activities contemplated inside the Stadio dei Marmi, are invited to attend the same by stationing themselves on the parterre of the sports facility in order to respect the architectural monument of the Foro Italico Park.

The public may be subjected, also by security personnel and by means of metal detectors, to checks aimed at avoiding the introduction of illicit, prohibited and/or dangerous materials and is required to follow the instructions provided by the security personnel, who may intervene to verify and non-comply with what is indicated in these Regulations.
