# ALLEGATO A6 REGOLAMENTO D'USO DELL'IMPIANTO

# OLYMPIC STADIUM OF ROME RULES OF CONDUCT AND RULES OF USE

(Art. 1 Octies of Legislative Decree 28/2003, converted and amended by Law 88/2003)

These Regulations for the use of the Stadium, provided for by Article 1-octies of Legislative Decree No. 28/2003, converted into Law No. 88/2003, are aimed at regulating access to and permanence within the sports facility where the event takes place, as well as behavior in the stands.

By FIR or Federation, we mean the Italian Rugby Federation.

Event means any sporting event that takes place in the Olympic Stadium of Rome, organized and/or managed by the Federation.

For the purposes of these regulations, a sports facility means all the areas pertaining to it, including the outdoor reserved area of the Olympic Stadium in Rome.

Access and permanence, for any reason, inside the sports facility, on the occasion of events, are regulated by these "regulations of use"; The purchase of the ticket implies its acceptance by the spectator.

Failure to comply with the same will result in the immediate termination of the service contract, with the consequent removal of the offender from the plant as well as the application of the sanctions provided for by the body competent to impose them, if it is a violation of the requirements imposed by law or regulations in force.

If the offender has already been sanctioned, in the same sports season, even in a different facility, for the same violation of the regulations of use, the sanction may be increased up to half of the maximum and a ban on access to sporting events may be imposed.

#### **PLEASE NOTE THAT:**

- Tickets for the event are not nominative: the name of the purchaser, not the holder, is indicated on the tickets; therefore, the purchased ticket may also be transferred to third parties, according to the regulated provisions of the organizer and according to the methods governed by the sales policies, also indicated through the ticketing company in support of the Federation. Any illegal access ticket will be confiscated by the Security Officers with the assistance of the Police;
- during the controls during access to the event, in addition to the access ticket, the
  possession of a valid identity document may be required, to be shown also at the
  request of the security staff or the FF. OO.;
- Admission is free for children up to 3 years old, but the parent must hold the child in their arms;
- the ticket must be kept until the exit of the stadium;
- the spectator has the right/duty to occupy the assigned seat and, therefore, with the purchase of the access ticket undertakes not to occupy different seats, even if not used by other subjects, unless expressly authorized by the Federation that organizes the event;

- Children aged 3 and over can enter only if they have an entrance ticket;
- Children under the age of three on the date of the race can access the facility without an access ticket provided that they do not occupy a seat;
- the spectator may be subjected, also by stewards and by means of metal detectors, to checks aimed at avoiding the introduction of illegal, prohibited and/or dangerous materials and is required to follow the instructions provided by the security staff;
- for reasons of public order, the Public Security Authority may limit or prohibit entry
  or stay at the event, even to persons who have a regular access ticket. Under no
  circumstances is access to the event allowed to persons subject to a warning for
  acts of sporting violence;
- the FIR is not liable for loss, accidents or damage to persons or property in the Stadium, unless the fact is directly attributable to its negligence and fault;
- the FIR cannot guarantee that the meeting will take place on the scheduled date and time; also reserves the right to reschedule the date and time of the race without prior notice and without incurring any kind of liability;
- In the event of a postponed or cancelled event, the refund will be made in accordance with the provisions of the ticket purchase contract. The FIR will not have any other obligation, other than that of the refund of the ticket, therefore no other liability can be attributed to the FIR for any title, reason, action. The refund or replacement of the ticket will take place only upon presentation and then return of the same;
- any spectator who is found in an area of the Stadium other than that indicated by the ticket in his possession will be accompanied back to occupy the seat validated by the ticket in his possession;
- No spectator shall / may remain standing during the course of the rugby match, in order not to obstruct the view of others, nor to recklessly occupy any escape routes, marshalling ladders, stands or positions that may cause damage to public safety;
- with the purchase of the ticket to access the Stadium, the spectator implicitly authorizes the FIR through the security personnel, to request checks on the person and, if necessary, to refuse entry, or to remove from the Stadium anyone who is not willing to undergo security checks;
- the purchase of the ticket valid for access and stay in the Stadium area entails: the
  acceptance of these Regulations. Failure to comply will result in the immediate
  termination of the performance contract, with the consequent removal of the
  offender from the Stadium, as well as the application of the sanctions provided for
  by law and regulations issued for this purpose by the FIR Italian Rugby
  Federation;

- the FIR, with the acceptance of these regulations, informs that inside the sports facility and in its immediate vicinity, the Public Security authorities carry out video surveillance activities with recording of images and audio as required by the Ministerial Decree of 30 June 2003 and the Ministerial Decree of 06.06.2005:
- To ensure a regular flow to the stadium, it is strongly recommended to enter the dedicated sector at least 45 minutes. Kick-off first.

#### **BANS**

The following behaviors are prohibited:

- express any form of racial, ethnic or religious discrimination or other manifestations of intolerance with chants or displaying writings;
- stop near passages, exits, entrances, along access routes, escape routes and any other escape route without justified reason;
- climbing on structures, climbing over fences and/or separators;
- stationed in sectors that do not correspond to the security purchased/owned;
- damage or tamper with the facilities, infrastructure and services of the plant in any way;
- introduce or possess poisons, harmful substances, flammable or soiling materials and drugs:
- introduce or offer for sale alcoholic beverages with an alcohol content higher than 5°, except for derogation authorizations for particular areas issued by the competent authority, subject to the favorable opinion of the Police Chief;
- introduce or possess stones, knives, objects capable of offending or suitable to be thrown, sound instruments, systems for the emission of light rays (laser pointers) and other objects that may cause disturbance or danger to the safety of all persons present in the installation;
- display material that obstructs visibility to other fans or emergency signs or that obstructs escape routes to the pitch;
- introduce and sell beverages contained in cans, glass or plastic bottles inside the sports facility; they must be poured into paper or plastic cups;
- introduce and display banners, placards, horizontal banners, weather vanes, documents, drawings, printed or written material, other than those explicitly authorized by the Security Operations Group at the request of the FIR; for authorized banners, they may not be displayed in spaces other than those indicated by the security personnel and must be removed at the end of the event (see banner procedure on <a href="https://www.federugby.it">www.federugby.it</a>).

In this regard, please note that in order to place a banner, access with choreographic objects or to exhibit similar content at the STADIO OLIMPICO DI ROMA it is necessary to be in possession of an authorization from the FIR and approved by the GOS. This authorization must be requested at the e-mail address <a href="mailto:sicurezza@pec.federugby.it">sicurezza@pec.federugby.it</a>, within 10 working days prior to the event. The request must be accompanied by the user's data and a copy of the document.

#### It is forbidden to:

- organize choreographies that are not authorized or that differ from those authorized by the Operational Group for Safety;
- enter and stay inside the facility in a state of intoxication or under the influence of narcotic or psychotropic substances;
- introduce helmets, umbrellas with rigid tips and any other object considered dangerous or likely to offend, even accidentally, the users present;
- enter or park any type of vehicle in places other than the areas intended for their parking;
- conduct commercial or promotional activities, display advertising material, collect donations, unless previously authorized and regulated by current security regulations, under penalty of confiscation of the material subject to such prohibited activities;
- throw waste material in places not intended for this purpose;
- actions that, in the opinion of the safety officers, constitute an obstacle to the conduct of the race, or are a disturbance or danger to other people;
- bring animals, with the exception of guide dogs for the blind or dogs trained for rescue;
- stand on the seats;
- field invasion and entry into forbidden areas;
- enter the facility again once you have left it before or during the event, except for invitations for post-race ceremonial functions organized by F.I.R.;
- introduce flagpoles that are not flexible, made of wood, iron or other material that can be used as a blunt object or cause damage, even accidentally;
- introduce drones or any remotely controlled flying object of any kind and class;
- musical instruments of any nature unless expressly authorized by the Organizer.

#### REASONS FOR EXPULSION FROM THE IMPLANT

Anyone who behaves violently, insultingly or offensively, discriminates ethnically or religiously or politically against other spectators or athletes in the sports facility, engages in political propaganda, causes damage to the sports facility, engages in conduct that is dangerous to the safety of other spectators, or has entered the stadium without a valid

ticket, occupies sorting routes or areas concerning escape routes, displays banners that are not authorised to enter and display them, introduces material that is prohibited by current legislation or by these Regulations of Use, or in any case contravenes the rules contained therein, will be removed from the Sports Facility and its appurtenances where the aforementioned regulations are valid, after the investigations carried out by the competent Authority.

## IT SHOULD BE NOTED THAT THE FOLLOWING ALSO CONSTITUTE A CRIME:

misrepresentation, possession of proper or improper weapons, display of emblems or symbols of associations that spread discrimination or violence for racial, ethnic, national or religious reasons, incitement to violence during competitive competitions, possession, throwing and use of dangerous material and pyrotechnic devices, climbing over separators and invasion of the field.

Finally, it should be noted that the system is controlled by an audio-video recording system positioned both indoors and outdoors, whose data are processed according to the provisions of Legislative Decree No. 196 of 30 June 2003 and subsequent amendments, GDPR 679/2016 and Ministerial Decree 06/06/2005.

#### **ANTI-INFRINGEMENT MODEL**

The use of electronic devices for the recording and/or transmission and/or production and/or distribution, in any way carried out, of any audio, video or audiovisual material or any information or data concerning the progress, conduct, or any other aspect of any match for betting activities is strictly prohibited within the Stadium. for commercial activities not previously authorized or for any other purpose that is in violation of these general terms and conditions, unless authorized or permitted by the FIR. The use of mobile phones is permitted only and exclusively for strictly personal and private use.

In the event of non-compliance with these general terms and conditions, access to the facility may be denied or, in any case, removal from the facility may be determined.

## OTHER EVENTS ORGANIZED BY THE FEDERATION

All those choreographic and communication materials that the FIR may consider introducing within the sports facility as part of institutional, promotional and/or marketing initiatives collateral to the conduct of the competition and/or other related events, as long as they are intended to take place within the sports facility and/or the areas pertaining to the same, do not require authorization from the GOS or other Authority.

#### **WARNINGS**

It should be noted that the system is controlled by an audio-video recording system positioned both indoors and outdoors, whose data are processed by the owner of the same according to the provisions of Legislative Decree no. 196 of 30 June 2003 and

Ministerial Decree 06/06/2005. The processing of personal data is carried out in compliance with the law.

Ticket holders give their explicit consent to the use of their image relating to the recording, reproduction and promotional-advertising exploitation by FIR on their communication channels and on any media support
